All Roads Lead to the Jesuit Order

The author shows repeated associations between Jesuits and major historical world events: Lincoln's assassination; the Titanic; Federal Reserve establishment etc.

While each conspiracy can't be 'proven', the doctrines of Rome and the Jesuit Order in her service are plain, that freedoms and liberties of the U.S. are seen as a clear and present danger, and can never truly coexist with Jesuitism.

I) Target America (pp. 1-17)

The Congress of Vienna was held 1814-15 after the Napoleonic Wars. Its high contracting parties were Russia, Prussia [Germany], Austria, and the Papal States under Pius VII.

The Jesuits held a congress at Verona in 1822, that the U.S. should be destroyed at all costs. A second meeting was held at the College of Chieri near Turin in 1825.

America's Monroe Doctrine held that any European expansion into the western hemisphere would be taken as an act of war.

II) President Andrew Jackson (pp. 18-29)

The Doctrine of States Rights holds that states may do whatever they wish; the logical conclusion of which is the end of the United States so states sought to secede.

III) Presidents Harrison, Taylor, and Buchanan (pp. 30-40)

Philosophers like notions of God as: "the Eternal Consciousness"; "Ground of Our Being"; "Infinite Principle"; and "Cosmic Force".

IV) President Abraham Lincoln (pp. 41-56)

In 1856, slave Dred Scott ran away to Kansas. U.S. Chief Justice and Roman Catholic Judge Taney (the Taney Decision) said the Negro had no rights.

In Baltimore, an Italian barber plotted to stab Lincoln while in his carriage.

Four people, all Roman Catholics, were tried and hanged for Lincoln's assassination.

V) The Sinking of the Titanic (pp. 57-63)

On 4/10/1912, Jesuit Master Francis Browne boarded the Titanic, but disembarked at the last stop at Queenstown, Ireland.

VI) World War One (pp. 64-70)

In 1917, Communists murdered the Russian Czar and his family.

William Franklin Sands, director of the Reserve Bank of New York, gave \$1M to the Bolsheviks. Jacob Schiff gave them \$20M.

In 1872, Bismarck outlawed the Jesuits with the Kulturkampf law.

VII) World War Two (pp. 71-83)

The Federal Reserve loaned millions to Hitler in the 1930s.

In Operation Keelhaul after WWII, Presidents Roosevelt and Eisenhower approved forced repatriation of 6M Orthodox Christians back into Russia, many of whom were tortured or killed.

VIII) President John F. Kennedy (pp. 84-98)

Avro Manhattan believed the Vietnam War was fought to create a Vatican power base in Southeast Asia. President Ngo Dinh Diem of South Vietnam was a Roman Catholic who ruled with an iron fist.

The day after Kennedy's assassination, the decision to stop U.S. action in Vietnam was reversed. Kennedy had also called for a return to a gold standard, and dismantling the Federal Reserve. Lyndon Johnson was acting he knew of the assassination, ducking repeatedly before shots went off. No autopsy was don on JFK's body.

X) Destruction in Oklahoma City (pp. 112-122)

168 people were killed in the Oklahoma City bombing on 4/19/1995.

Air blast force is mostly ineffective against reinforced concrete beams and columns.

The official story was a fertiliser bomb was detonated.

No ATF agents were at work in the Murrah building on the day.

CIA veterans James Black and Ron Jackson swore an affidavit they were part of a Committee of 10 which carried out the attack.

The purpose of the bombing was to get Congress to pass the anti-terrorism bill without debate. This is part of an ongoing conditioning program to determine how many freedoms Americans are willing to give up in order to 'feel safe'.

XI) World Trade Center Attack (pp. 123-137)

In April 1995 after Oklahoma, 49% said it would be necessary to give up some civil liberties.

Ex-Jesuit Alberto Rivera claimed the Vatican created Islam to destroy Christians and Jews, protect Roman Catholics, and capture Jerusalem for the pope. [p135]
