**Introduction (pp. 11-14)**

**I) Marketing Blitz: Selling 'Gay Rights' to America (pp. 17-38)**

The Stonewall riot happened 6/11/1969 at NYC's Stonewall Inn when sodomites resisted police commands to disperse.

1973, the APA removed homosexuality from its list of 'mental illnesses'.

In 1978, Alan P. Bell and Martin S. Wineburg reported 43% of homosexuals had over 500 sex partners in their lifetime.

He who frames the *terms* of the debate nearly always wins.

Historical persons are useful since they can't contest anything or sue for libel.

One strategy was to jam homohatred by linking it to Nazi horror.

Belief in miracles requires belief in normal stability, and a reality beyond nature.

In 1999, 54% accepted homosexuality..

Sexually abused males are up to seven times more likely to self-identify as gay.

Destroying a child's innocence makes the perpetrator aware of his own corruption.

## **II) Buying the Big Lie: The Myth of Church-State Separation (pp. 39-59)**

“Separation”, “Church”, or “State” are not in the 1A.

In 1811, Supreme Court Justice Joseph Story in *Commentary on the Constitution of the United States* explained the SCOTUS position on the 1A:

“The real object of the [1A] was, not to countenance, much less to advance Mahometanism, or Judaism, or infidelity, by prostrating Christianity; but to exclude all rivalry among Christian sects, and to prevent any national ecclesiastical establishment, which should give to an hierarchy the exclusive patronage of the national government.” [p44]

In 1947, *Everson v. Board of Education*, Supreme Court Justice Hugo Black created a new principle: “The First Amendment has erected a wall between church and state. That wall must be kept high and impregnable.

We could not approve the slightest breach.” [p47].

SCOTUS justices live among the elite.

### **III) Killer Culture: Who’s Selling Sex and Rebellion to Your Children? (pp. 60-81)**

Five U.S. companies are responsible for youth culture: Murdoch’s Newscorp; Disney; Viacom; Universal Vivendi, and AOL/Time Warner.

Everything on MTV is a commercial.

“Suspension” is the act of hanging the human body from hooks pierced through the flesh. It is an edgy ‘body modification’ practice.

“Bug-chasing” is the ultimate experience for those who wish to acquire STDs (from “gift-givers”).

Two characteristics of self-mutilators are: mental disintegration and rage toward a powerful figure (usually a parent).

### **IV) Multicultural Madness: How Western Culture Was Turned Upside Down in One Generation (pp. 82-104)**

MC claims all religions, sexualities, and life are equal. On the last, PETA’s catchphrase is, “a rat is a pig is a dog is a boy”.

Marketing is application of psychology to persuasion directly targeting emotion.

### **V) Family Meltdown: The Campaign to Destroy Marriage (pp. 105-126)**

“All it takes is for one confused spouse who thinks divorce will solve unhappiness.”

Under the hostile court system the state then controls children and marital assets.

Fathers realise divorce means loss of children.

“No-fault” divorce means, “divorce because it suits the mood of at least one partner”. This was the tool used to cripple marriage since the late ‘60s. ‘Paragon of values’ Ronald Reagan.

“Feminism stresses the indistinguishability of prostitution, marriage, and sexual harassment”.

Divorce forces children to become adults before they are ready.

Lesbians have long held claim to leading the feminist revolution.

### **VI) Obsessed With Sex: How Fraudulent Science Unleashed a Catastrophic ‘Revolution’ (pp. 127-148)**

12% of the web is porn.

*Time*, *Life*, and *Look* all portrayed Rockefeller-funded pervert Alfred Kinsey as a conservative Republican academic. His data came from serial pedophile Rex King, also Nazi pedophile Fritz von Balluseck.

### **VII) Sabotaging Our Schools: How Radicals Have Hijacked America’s Education System (pp. 149-167)**
