The polio vaccine was contaminated by the chimp coryza virus, also called Respiratory Syncytial Virus (RSV).

Close contact between any immunocompromised person and one vaccinated with OPV should be avoided for one month.

In 2011, India registered 47,500 new cases of non-polio acute flaccid paralysis (NPAFP).

By October 1976, 33 had died after taking the experimental Swine Flu vaccine. By December there were 500 Guillan-Barre cases. On 12/16/1976 after 46M shots were given, the programme was cancelled.

Vaccine-induced hypothesised SIDS mechanisms include: autoimmune overload; genetic susceptibility; IS immaturity; chemical additives and adjuvants.
